# **Royal Travel Fund**

### Purpose

The purpose of this Fund is to provide support to the Crown of the Kingdom of Lochac to travel to events around the Kingdom.

### Definitions

**Royal Travel Fund**: Council of the Purse, made up of the Kingdom Seneschal, The Chancellor of the Exchequer, Deputy to the Chancellor of the Exchequer, and Their Royal Majesties

**Exchequer**: Chancellor of the Exchequer of the Kingdom of Lochac, the Kingdom's (chief) Financial Officer.

**Deputy Exchequer**: Deputy to the Chancellor of the Exchequer. This officer resides in the country the Exchequer does not.

Kingdom Seneschal: Chief Kingdom Administrator

**The Crown:** the Sovereign (winner of the Crown Tournament and who has been crowned with the title of King or Queen) and their Consort (person who was fought for in the Crown Tournament and who has been crowned with the title of King or Queen).

**Branch:** An individual SCA group within the jurisdiction of the Kingdom of Lochac (Australia and New Zealand/Aotearoa)

# Scope

This fund is primarily designed to assist the Crown of Lochac to travel around the Kingdom during their reign. There is an option to use a <u>limited portion</u> of this allowance for Inter-Kingdom travel (e.g. to Pennsic War).

To remove ambiguity, support for travel includes, but is not limited to:

- Airfares (including for minor dependants if required)
- Excess baggage charges
- Ferry tickets
- Car rentals
- Accommodation
- Car fuel costs

# Value

As from the first reign of 2023 the value of the fund will be \$4900. Using best available data, the Chancellor of the Exchequer will propose a travel allowance for the incoming Crown towards the end of each reign. This will ensure that the value will increase consistent with CPI indexing estimates (see Attached). A final amount will be agreed by the Council of the Purse prior to the upcoming coronation.

The terms of the fund also allow for the Crown to use a portion of the fund to assist with travel to another Kingdom. This is set at no more than 25% of their reigns allowance. This too, is shown in Figure 1, below.

**See Attachment 1:** The table attached below is based on Quarterly assessments of the <u>Australian Consumer</u> <u>Price Index</u>. It provides the most update information at the time of publication of this policy. It is suggested that the website be reviewed on a regular basis, so that the forecast percentages are more accurate.

### **Extraordinary events**

Should there be an event that requires the Crown at short notice to travel to an event, an extraordinary allowance amount of no more than \$500 can be applied for. As this will be during Their reign, TRM cannot vote on this allowance being approved. An Extraordinary Council of Extraordinary Expenditure will be called for this purpose. Voting members on the council will consist of the Kingdom Seneschal, Chancellor of the Exchequer, Deputy Chancellor of the Exchequer, Earl Marshal and the Arts and Sciences Minister. Where the Kingdom Officer has stepped into a Crown role, the nominated Deputy will be included in process.

# Abertridwr Endowment

### History

After the closure of the Branch known as Abertridwr, a poll of the populace resulted in a portion of Branch funds could be used to support the Royal Travel Fund.

#### Scope

Through this contribution was born the Abertridwr Endowment, which provides for **\$500 per** calendar year to attend a major camping event held in Western Australia, similar to Abertridwr's Pencampwr event.

### Conditions of the fund

This endowment **is only available once per calendar year**, to attend the major camping event in Western Australia. The total value of the fund is \$500. If the Crown decides not to attend in a particular year, that portion of the endowment is will be **held over for an additional year** (i.e. rolls forward). Should an event not be held in a particular year, that portion of the endowment is passed into the regular Kingdom Funds. For example, in 2023, quene katherine used this fund to attend Great Western Raids and therefore, is not available for the remainder of 2023. However, it would be available during 2024 for one use only.

### **Review Period**

This policy is required to be reviewed for its relevance to the current situations of the Kingdom of Lochac at minimum once every tenure of the Chancellor of the Exchequer and the Kingdom Seneschal, therefore being at minimum every two years. The value of the allowance within this fund is required to be reviewed as necessary by the (current) Chancellor of the Exchequer (or their allocated Deputy) and should be reviewed at the beginning of the tenure of each Exchequer.
